1. INVITATION TO BID:

- i. **State Bank of India – Sri Lanka** (herein after referred to as ‘**SBI-SL/the Bank**’) is having its Head Office at Fort Colombo, various other branches of State Bank of India – Sri Lanka at Colombo and Kandy. This Request for Proposal (RFP) has been issued by **the Bank** for procurement of firewall.
- ii. In order to meet the IT hardware requirement, the Bank proposes to invite tenders from eligible vendors to undertake delivery of firewall as per details/**scope of work** mentioned in **Annexure-A** of this RFP document.
- iii. Bidder shall mean any entity (i.e. juristic person) who meets the **eligibility criteria given in Annexure-B** of this RFP and willing to provide the goods and services as required in this bidding document. The interested Bidders who agree to all the terms and conditions contained in this document may submit their Bids with the information desired in this bidding document (Request for Proposal).
- iv. The purpose of SBI-SL behind this RFP is to seek a detailed technical and commercial proposal for procurement of the IT hardware/product and services desired in this document. The proposed product must integrate with Bank’s existing infrastructure seamlessly.
- v. This document shall not be transferred, reproduced or otherwise used for purpose other than for which it is specifically issued.
- vi. Interested Bidders are advised to go through the entire document before submission of Bids to avoid any chance of elimination. The eligible Bidders desirous of taking up the project for supply of proposed product and services for SBI-SL are invited to submit their financial proposal in response to this RFP. The criteria and the actual process of evaluation of the responses to this RFP and subsequent selection of the successful Bidder will be entirely at Bank’s discretion. This RFP seeks proposal from Bidders who have the necessary experience, capability & expertise to provide SBI-SL the proposed hardware and services adhering to Bank’s requirements outlined in this RFP.

2. Disclaimer:

- i. The information contained in this RFP document or information provided subsequently to Bidder(s) whether verbally or in documentary form/email by or on behalf of State Bank of India – Sri Lanka (Bank), is subject to the terms and conditions set out in this RFP document.
- ii. This RFP is not an offer by State Bank of India – Sri Lanka, but an invitation to receive responses from the eligible Bidders. - iii. The purpose of this RFP is to provide the Bidder(s) with information to assist preparation of their Bid proposals. Bank may in its absolute discretion, but without being under any obligation to do so, update, amend or supplement the information in this RFP.

4. Bid Preparation and submission:

- i. The Bid is to be submitted in two separate envelopes. One of the envelope is to be prominently marked as **Financial Proposal for procurement of Firewall Units in response to the RFP No. LK/CHO/RFP/SYS01 Date29/07/2021.** This envelope should contain following documents and **properly sealed.**

 - Completed Annexure-D
 - Completed Annexure-E
 - Required Document to Annexure - B, D, and E
- ii. Cutoff date and time for submission of bids is 3pm on 09.08.2021.

5. Period of Validity of Bids:

- a. Bid should be valid for minimum 10 days form the date of cut-off
i.e. 09.08.2021

6. Contacting the Bank:

- i. No Bidder shall contact the Bank on any matter relating to its Bid, from the time of opening of Price Bid to the time, the Contract is awarded.
- ii. Any effort by a Bidder to influence the Bank in its decisions on Bid evaluation, Bid comparison or contract award may result in the rejection of the Bidder's Bid.

7. Award Criteria:

- i. Bank will notify successful Bidder in writing by letter or fax/email that its Bid has been accepted.

- ii. The successful Bidder will have to submit Non-disclosure Agreement (wherever applicable), together with acceptance of all terms and conditions of RFP.
- iii. Copy of board resolution or power of attorney showing that the signatory has been duly authorized to sign the acceptance letter, contract and NDA should be submitted.

8. Compliance with IS Security Policy:

The Vendor shall have to comply with Bank's IT & IS Security policy in key concern areas relevant to the RFP, details of which will be shared with the finally selected Bidder. Some of the key areas are as under:

- i. Responsibilities for data and application privacy and confidentiality
- ii. Responsibilities on system and software access control and administration
- iii. Data Encryption/Protection requirements of the Bank.
- iv. In general, confidentiality, integrity and availability must be ensured.

Scope of Work

1. Delivery of Firewall Equipment as per BOM within 4 weeks of Purchase Order from the Bank at four locations as mentioned in Schedule of Events.
2. Return merchandise authorization (RMA) – replacement of faulty device/part(s) should be fully carried out by the selected bidder, during the warranty period.
3. All products should have TAC support with products principals in the case of technical issues
- 4 Implementation and commissioning should complete as per the bank requirement.
- 5 Bank IT team should be the primary contact during the implementation
- 6 Implementation should be fully comply with the bank IS policy.
- 7 Implementation should carry out with the daily operation of the bank and it should not be interrupted to bank operation.
- 8 All Fortigate firewalls and Cisco Firewalls should have RMA (Hardware) in 24*7*4
- 9 Selected bidder should provide local engineering service support based on 24*7*4 Onsite only.
