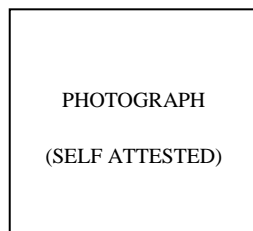

- For salaried individuals a set of Bank statements and pay slips for the last three months / for professionals and self-employed supporting documents to prove the turnover and source of income such as IT Return and account statements for last six months
- A letter from the employer confirming the employment details and for self-employed Business Registration Certificate
- Copy of National Identity Card/ Passport or Driving License for proof of Identity
- Copy of recent Electricity Bill/ Telephone Bill/ any other document acceptable to the Bank, for proof of residency
- Latest Passport size photograph
- Latest monthly salary slip showing deductions of guarantors (only if the guarantors are requested by the bank)
- Copy of National Identity Card/ Passport or Driving License of guarantors (only if the guarantors are requested by the bank)
- Original Invoice/ Valuation Report (for pre-owned vehicle) of the vehicle.
- If it is a pre-owned vehicle, a letter from the seller confirming the selling price, copy of NIC of the seller and bank details for remitting the funds
- Original Certificate of Registration (for pre-owned vehicle)
- Copy of the vehicle insurance (for pre-owned vehicle)
- For self-employed and businessman, Audited Balance Sheet and Profit and Loss statement for 2 years, IT return (if loan amount is more than Rs.4 Mio)
